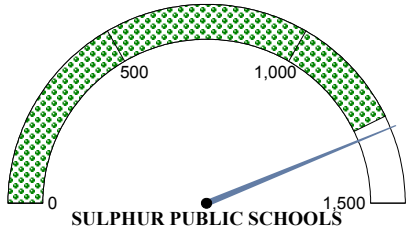

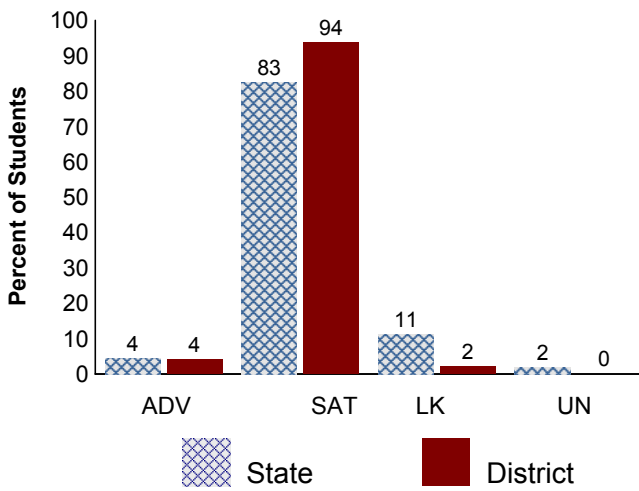

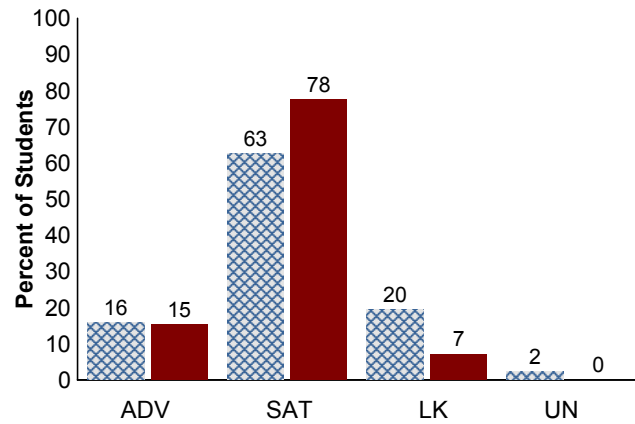

All Students Tested



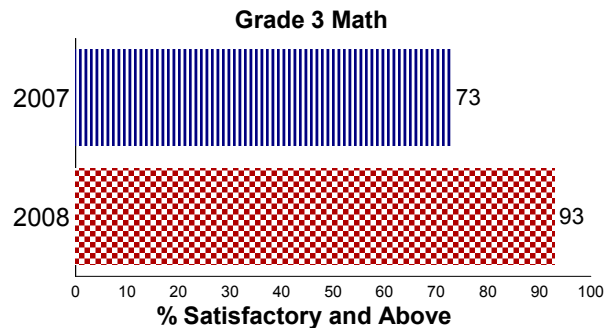
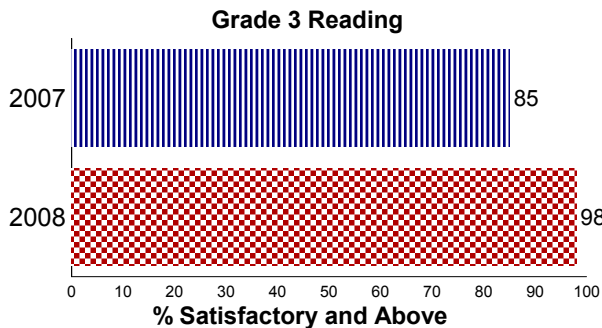
